


We envision an equitably funded Early Learning and Child Care (ELCC) system that provides culturally affirming environments and curriculum for all children to flourish wherever they live in Canada.

CCCF's Strategic Plan 2022-25 has kept us focused on our key priorities of:

- Community Partnerships & Relationships
- Government Policy & Practice
- Increased Organizational Capacity

These priorities guide our work. The well-being of children is at the heart of what we do. This year, we have been engaged in developing our valued relationships to help the sector strengthen to ensure we implement the Canada-wide early learning and child care program. CCCF membership continues to grow. As Affiliate organizations increase their membership, it positively impacts CCCF. Gradual, positive growth.

Canada-wide Child Care Plan

The CCCF fully supports the transformative Canada-Wide Early Learning and Child Care Plan (CWELCC). We've engaged with our affiliates and partners to build capacity, share knowledge, and ensure the plan is solidified into social contracts and expectations that benefit families and children. Early Childhood Educators (ECEs) are the backbone of this system, and our efforts are focused on supporting their critical role. Throughout the year, we collaborated with affiliates across Canada to shape a child care system that prioritizes quality for both

early childhood educators. The generous support from the Muttart Foundation has been essential in growing our membership and providing the necessary administrative and operational support to keep Canada's early learning and childcare sector connected and focused on best practices.

Workforce Strategy Vision

CCCF has built on previous workforce strategies, including producing a comprehensive five-page document that consolidates the best workforce support initiatives from our affiliates. This vision document is designed to support and inform provincial and territorial work, focusing on essential components such as:

- Fair, market-competitive wages reflective of the uniqueness of ECEs
- Clear educational requirements and a vision for ECE credentials
- · Ongoing professional development
- Pedagogical standards
- Comprehensive benefits (group insurance, pensions, and mental health days)
- An inclusive workforce

We believe that clarity and common sense are essential to completing this strategy.

Expanded National and Regional Engagement

CCCF connected with Canada's far north ELCC sector through the Yukon Child Care Association (YCCA) and the NWT Early Childhood Association (NWTECA). Although not yet full CCCF affiliates, their involvement enriches our pan-Canadian knowledge and capacity.

We also supported the Saskatchewan Early Learning and Care Caucus (SKLC) in their efforts to advocate for a licensed "Family Home" agency model, similar to those operating in Alberta, Newfoundland, Prince Edward Island and Ontario.

Strengthened CCCF Board of Directors involvement

CCCF board members are involved in Early Learning and Child Care locally, provincially and/or nationally. The board table provides a chance to learn from each other and support one another as we transition our sector. Specifically, we have one board member on the CCCF National Quality Statement on ELCC advisory committee; Three board members joined us with the Child Care Now 10-days of Action campaign; and one member joined us at the ECE summit in Ottawa in November which was hosted by Child Care Now and partially supported financially by Muttart; Two members engaged with the leaders caucuses in Alberta and Saskatchewan; and nine board members engaged in plans for the Fall 2025 ECE Conference in PEI.

Advocacy and Media Presence

The CCCF has played a pivotal role in public advocacy through public dialogue with extensive media engagement. Our efforts have been highlighted in national outlets such as The Globe and Mail, The Toronto Star, CBC Radio, and various local and community media platforms.

Looking Ahead

2025-26 will be an important transition year. Though there was welcome continuity in the election of a government supportive of child care, we are preparing for new ministerial changes and developments. We will continue to work closely with governments at both federal and provincial levels to continue to roll out the national child care plan and to create the fulsome workforce strategy needed for its success.

During the next fiscal year, we will be working closely with Affiliates regarding membership engagement. This fiscal year is the end of the 3-year Innovations Fund project called E3: Upgrading CCCF Family Child Care Resources. We are ready to launch our new and exciting Family Child Care training supports across Canada. We are prepared to engage in a strategic planning process to keep CCCF focused on its mission – achieving excellence in early learning and child care.

We hope this report provides our members with a deeper understanding of the work we have done and continue to do, during this transitional period in ELCC in Canada. The CCCF, along with its affiliates and partners, is navigating the same challenges and opportunities in this time of change.

Finally, we express our sincere gratitude to our affiliates, partners, and the CCCF Board of Directors for their unwavering commitment and guidance. A special thanks to our dedicated colleagues —Claire McLaughlin, Robin McMillan, and Suzanne Schlechte—for their professionalism and commitment to our mission.

FEDERAL GOVERNMENT AND PROVINCIAL RELATIONS

Provincial Territorial CCCF ECE Presentation on Workforce Initiatives to Minister's Table

In April, CCCF's Interim CEO, Marni Flaherty, together with our affiliates, had the privilege of presenting our national workforce goals and initiatives for the Early Learning and Child Care (ELCC) sector to the Provincial/Territorial Ministers responsible for ELCC workforce strategies. Joined by affiliates from Ontario, Manitoba, and Prince Edward Island, we shared CCCF's workforce vision, including proposed wage grids and improved working condition initiatives. Our presentation emphasized the critical recognition and value of Early Childhood Educators (ECEs) in achieving the objectives of the Canada-Wide Early Learning and Child Care (CWELCC) plan.

Advocacy with National Partners on ELCC for Spring Federal Election

During the spring federal election campaign, CCCF engaged members in advocating for affordable, high-quality child care and collaborated closely with Child Care Now on their Ten Days of Action for the \$10-a-day plan.

- Developed online advocacy tools promoting higher wages and better working conditions.
- Supported the expansion of affordable child care and implementation of the National Child Care Plan.

We also worked alongside the National Advisory Council on ELCC to inform policy direction. Meetings with Minister Jenna Sudds, her department, and affiliates across Canada focused on advancing a child care workforce strategy. Through research, surveys, open letters, and op-eds, we kept ELCC issues at the forefront nationally.

World Forum on Early Learning & Care (April 2024, Vancouver)

CCCF Board, staff, affiliates and caucus leaders from Saskatchewan and Alberta participated in this global event, connecting with 700+ delegates from 50+ countries.

Key highlights:

- CCCF co-led the sold-out O'Canada Day pre-conference, featuring keynote speakers from Canadian ELCC organizations, governments, and child care leadership.
- Promoted the Forum widely through sector networks, our website, and e-blasts, exceeding attendance expectations and fulfilling all deliverables under the World Forum Alliance Partnership.


In partnership with the Early Childhood Development Association of PEI, CCCF co-organized the annual conference. CCCF's Board hosted a panel discussion and facilitated feedback on the draft update to our National Statement on Quality ELCC, developed by researcher Kathleen Flanagan.

POLICY AND RESEARCH INITIATIVES

Updating the National Statement on Quality Early Learning and Child Care

CCCF is reviewing and updating its National Statement on Quality Early Learning and Child Care, originally developed in 1991 and last revised in 2007.

- Kathleen Flanagan, ELCC researcher, is leading the update in partnership with CCCF's Board, affiliates, and staff.
- The update reflects current ELCC developments, including the Canada-Wide ELCC initiative and provincial/territorial funding agreements



MEMBERSHIP ENGAGEMENT, PROJECTS & INITIATIVES

This past year, CCCF strengthened partnerships and supported innovation across the ELCC sector:

- Collaborated with Western University's Sleep Laboratory and Child Health & Physical Activity Lab.
- Co-authored "A Policy Analysis of Sleep-Related Legislation for Canadian Licensed Childcare Facilities" with experts from UBC, UWO, and other leading institutions.
- Supported CPCHE initiatives, including Healthy Environments for Learning Day and sustainabilityfocused resources.
- Developed MOUs with partners such as Canadian Children's Literacy Foundation, Let's Talk Science,
 Outdoor Play Canada, Storypark, Active for Life, and Kids Included.
- Served as project advisors on several initiatives, including SPROUT-Able (outdoor play access), literacy development, and child care movement policy.
- Expanded networks supporting ECEs in Nunavut through collaboration with local organizations.
- · Presented at the Home Child Care Association Conference (Hamilton).

Engage, Enable & Empower (E3) Family Child Care Training Project

After three successful pilot launches — two in English and one in French — CCCF officially launched the 10-module online Family Child Care Training Course in spring 2024.

- Downloadable multilingual resources.
- Comprehensive course book (available in our e-store).
- Free monthly FCC newsletter.
- Virtual Community of Practice with 1,100+ members.
- Dedicated FCC Pinterest page featuring curated resources.

Alberta &. Saskatchewan Early Learning Leadership Caucuses

.With support from the Muttart Foundation, CCCF strengthened collaboration between leadership groups in Alberta and Saskatchewan, connecting public policy to practice.

- · Developed dedicated caucus webpages on the CCCF site
- Finalized Terms of Reference for both groups

Partnership with Andrew Fleck Children's Services

This partnership began as logistical support and has evolved into a multi-faceted collaboration, including:


